#### SELECTION CRITERIA:

Selectees to the RB Hall of Fame shall be living individuals with six or more years of outstanding volunteer service including three years in a leadership role, resulting in significant contributions to Rancho Bernardo.

#### CLARIFICATIONS:

1. The leadership positions may have been as the leader of an organization, committee, or project.
2. Exclude service or leadership for which the candidate received payment.
3. Exclude service or leadership that resulted in contributions of a religious or political nature.
4. Typical organizations to cite are those designed to serve others in Rancho Bernardo, enhance the quality of life in RB, improve health or education in RB, or foster the civic or cultural life of RB. The focus of your nomination should be the significant contributions to Rancho Bernardo that resulted from the nominee's outstanding volunteer service and leadership.
